3. Action Items:

a. 3-Year Parking Rate Structure (attachment: 3-Year Parking Rate Structure)

To ensure a stable revenue stream to keep pace with inflation and the ongoing operating and deferred maintenance costs of the parking auxiliary enterprise as well as ensuring continuing support to the General Fund in future years, a rate adjustment to the daily parking fee of \$.25 per year is proposed for July 1, 2019, July 1, 2020 and July 1, 2021. The daily fee pricing structure was most recently adjusted by ABOD by \$.25 on July 1, 2016 and by an additional \$.25 on July 1, 2017. Prior to that, rates had not been adjusted since July 1, 2013. Consistent with prior ABOD guidance, rates are held below 50 percent of downtown market. The institutional Chief Business Officers have reviewed and supported this 3-year rate adjustment.
