Call to Order

Approval of Minutes

Chairperson's Report

Marcia Walsh-Aziz informed the board of the process to fill the open CU Denver Student board position. Applications are due April 29.

Information Items

A. Guest Speaker: Thomas Beck, Chair of CU Denver Faculty Assembly Ethnic Diversity Committee

Thomas Beck presented information about the Ethnic Diversity Committee, a subcommittee of the CU Denver Faculty Assembly and the current efforts of the committee that relate to the ACPD CAB such as police violence, violence driven by hate, and supporting DACA students.

B. Social Media Presence

Marcia Walsh-Aziz opened up a discussion about ACPD CAB having their own social media based on the need to support two way communication between the CAB and the campus community. The board is supportive of ACPD CAB having their own social media presence.

On a separate note, the CAB believe the ACPD should have their own social media presence to help with community collaboration, connection, and keeping the campus informed during dangerous situations.

C. Emergency Communications AEC Statement

B. Campus Climate Survey Working Group

Megan Cullen proposed a subcommittee or working group to look at ACPD CAB hosting a data gathering survey about police and community relations. The original survey and community engagement committee containing Lauren, Megan, Elena, & Cassy would be interested in taking this on. The board will continue to discuss this topic at a future meeting.
