Approval of Agenda and Minutes

Jered shared that CU Denver seeks to relocate one of the Auraria designated smoking zones, so he came to ensure that SACAB was in agreement about the new location. He told the group that the current location at Benson Terrace is now in the heart of their pedestrian area, so CU Denver is requesting that the zone be moved to the west end of North Classroom. There are currently bike racks in that space, however, with the installation of the new covered bike parking, the group felt good about removing a couple of the current, outdoor racks to make room for the updated smoking zone. Jered and Carl Meese also shared that they would outfit the space with a receptacle for cigarette butts as well as a bench or benches for the area. SACAB had no other questions or concerns about the relocation.
