- Campus Update: Angela LeValley
  - No updates, other than traffic in Tivoli has been a little heavier than last semester.
  - She reminded everyone that today (29 Jan) is the last day to opt-in to the RTD pass. She did mention that the Tivoli bookstore is doing a 25% discount on school and art supplies. She mentioned that the bookstore continues to have flash sales; she recommended following the Tivoli bookstore on social media to find ongoing deals and promotions.

## □ Public Comment

X followed up with SACAB regarding the ACPD body Cam resolution. He inquired as to when SACAB would bring in BIPOC students for input. The BIPOC resolution was brought into the Metro State. He stated that he would love to see the BIPOC resolution that the various SGAs have drafted in order to better coordinate. He raised the question: "What does defunding the police look like? What does it look like going forward". He stated he is curious to see what SACAB's ACPD resolution looks like, given they have been working on it for months. He stated that if he was being honest, knowing he cannot speak for all BIPOC student, but that most students are working 2-3 jobs, and therefore might not be

- able to meet during business hours in order to contribute to the SACAB ACPD resolution. He suggested that SACAB could conduct a survey in order to better reflect student's input for the ACPD. This could help separate the interests of Faculty, students, etc. He stated he would like a formal request to hear from BIPOC students who have drafted parts of the resolution. He finished by
- o Dominique requested Kathryn Martinez, Chair of the Institute for Gender Care and Advocacy, and Nastasia. Another good place is going to the department's websites.
- O Dominique mentioned that the ACPD resolution in regard to bodycams is something she is quite passionate about. She mentioned that the resolution may be taking longer, because earlier, SACAB maybe jumped the gun a little, and now wants to incorporate student feedback.
- Olivia thanked X for being in the meeting. Olivia clarified that the resolution that X referenced throughout his communication this meeting was the Safer Spaces Resolution. She inquired if X thought the best way to communicate about the S.S. Resolution is to have the other orgs come directly to SACAB.
- X stated that he did think that it was best, because SACAB is recorded and a matter of public record.
  That way, there would be a public record of the meeting.
