

The Student Advisory Committee to the Auraria Board Records Request Resolution

WHEREAS, Effective July 1, 1989, there is hereby created a new board of directors of the Auraria Higher Education Center, referred as the “Auraria Board” or “Auraria Board of Directors”

WHEREAS, The establishment of The Student Advisory Committee to the Auraria Board of Directors (“SACAB”) was established, and operates, pursuant to 23-70-102(c)(I), 9 C.R.S. (1988 Repl. Vol.), which provides that: An advisory committee of six (6) members who are full-time students shall be elected, two (2) from each of the student bodies of each of the three (3) schools governed by the Auraria Board

WHEREAS, SACAB shall represent the interests of the students of the Community College of Denver (“CCD”), Metropolitan State College of Denver (“Metro State”), and the University of Colorado Denver – Downtown Denver Campus (“UCD”) (collectively, CCD, Metro State, and UCD shall be referred to as the “Constituent Institutions”) to the Board of Directors of the Auraria Higher Education Center (the “Auraria Board”) on matters pertaining to the Auraria Higher Education Center (“AHEC”)

WHEREAS, The Duties of SACAB include but not limited to:

- As representatives of all of the students of the Constituent Institutions, considering and investigating any matter relating to planning, development, operation and organization of AHEC
- As representatives of all of the students of the Constituent Institutions, advising, making recommendations to, and formulating proposals for action by, the Auraria Board regarding any matter relating to planning, development, operation and organization of AHEC.
- Investigating and making recommendations to the Auraria Board regarding all consumer concerns related to the operation of the Auraria Campus of the Bond Funded Facilities

WHEREAS, The Duties of ABOD include but not limited to:

- Plan, construct, own, lease, dispose of, acquire, operate, maintain, and manage the physical plant, facilities, buildings, and grounds of the Auraria Campus, and to allocate among the constituent institutions suitable space on the Auraria Campus, in accordance with their needs.
- Provide auxiliary services for the campus, including parking, daycare, the Tivoli Student Union with a campus bookstore, food service, student services and conference space, and campus police and security services.

WHEREAS, The Mission of Auraria Higher Education Center Mission, Vision, & Values include:

Mission: The Auraria Higher Education Center (AHEC) is committed to providing an effective, efficient, and supportive environment that facilitates the missions of the Community College of Denver, Metropolitan State University of Denver, and University of Colorado Denver.

Vision: Provide quality services that support quality education.

Values: The purpose of AHEC is to support and serve the Community College of Denver, Metropolitan State University of Denver, and University of Colorado Denver, and to facilitate the achievement of their goals and objectives.

The AHEC team is committed to the long-term success and development of the Auraria Campus.

We strive to provide a safe and open environment for all employees and commit to the following in our daily activities:

- Respect
- Courtesy
- Honesty
- Trust
- Consistency
- Service

We commit to living these values by:

- Actively listening to others
- Being open to change
- Communicating and collaborating
- Accepting responsibility for our actions
- Working together as a unified “One Auraria” Team

WHEREAS, AHEC put for an Open Records Policy AHEC approved by the Auraria Board of Directors in October but never presented this policy or brought this policy to SACAB and this change to the records access did not take inconsideration SACABs feedback

WHEREAS, SACAB only has records for SACAB affairs from 2006 to present electronically, and the Auraria Board of Directors from 2014-present respectively

WHEREAS, Since SACAB is an agency of the AHEC, and the Auraria Board of Directors

WHEREAS, for SACAB to fulfill its establishment and effectively carry out its duties requires access to records for SACAB, the Auraria Board and AHEC

WHEREAS, SACAB, AHEC, and ABOD are one Auraria Team

NOW THEREFORE BE IT RESOLVED, SACAB request that the records for SACAB since its inception be found and digitized to its secured database and copies of such records within its office from 1988 to 2006 respectively

BE IT RESOLVED, SACAB request the records for AHEC and the Auraria Board of Directors that from 1970-2013 respectively be digitized and added to SACAB's database and copies of said records be available to SACAB within its office

BE IT RESOLVED, SACAB request that AHEC accommodate such request and the Auraria Board of Directors fulfill such request immediately in commitment to AHEC's values of "communicating and collaborating"

BE IT RESOLVED, SACAB will work with the appropriate AHEC staff to ensure the fulfillment of this project

BE IT RESOLVED, SACAB asks the Auraria Board of Directors and Auraria Higher Education Center fulfill this request and pay the monetary means for such request and support SACAB in its fulfillment of duties and its establishment under the law.
